JLS Welcomes Highly Trained New Member Class

The Junior League of Springfield welcomed one of the largest new member classes for its 2012-2013 year with 55 women completing training and volunteer hours. Many new members joined JLS as current leaders elsewhere in the community. They have already been through a lot of training, job experience and service to the community. Each member brings this experience, career leadership, and diversity to the organization making JLS even stronger. Because they came into the JLS as leaders, many of the new members are already leaders of committees for the 2013-2014 year, and several have been appointed as committee chairs and assistant chairs.

Commitment to train members is what sets JLS apart from other volunteer organizations, and assists JLS in fulfilling

the mission of the organization. This training provides skills for members to use as they serve on other charitable boards, fulfill the current focus of JLS to assist with prevention of child abuse and neglect in the community and teaches additional skills to further the member's careers and education. JLS is strongly committed to recruiting strong female leaders in the community and continue training all members to continue to serve.

As new members, JLS requires new member meetings, general membership meetings, JLS orientation, a Know Your City tour, volunteering at the Plaid Door resale boutique for at least six hours during the year, volunteering on one Done in a Day project and at Pitter Pat along with fulfilling two training credits.

Thank you for allowing me to serve as the 2012-13 President of the Junior League. It has been my pleasure to serve over 600 women as we continue to focus on the prevention of child abuse and neglect.

I am excited to share that we committed \$96,150 to the community through our Done in a Day opportunities, discretionary grants and our commitment to fund the

Isabel's House development director position and their endowment. We have also volunteered 26,603 hours through the Junior League and 17,557 within the community.

During our Annual Meeting this year, 54 New Actives were welcomed into the League and we already have 73 New Members committed to the 2013-14 League year. In addition, two of our New Actives graduated from Leadership Springfield Class 28. Two of our New Actives were also recognized as 40 Under 40 recipients through the Springfield Business Journal and one recognized for 20 Under 30 through 417 Magazine. I am excited to see what the future holds for these ladies.

We are finalizing the video project that began last year. Our goal is for the final product to be used as a public service announcement that highlights the League's ability to train members, improve the community, create lifelong friendships and empower each other to serve within the League and the community. Thank you to everyone who has made this project a reality.

In closing, I would like to thank everyone for their generous donations of time, talent and treasure this year. We exceeded \$10,000 in donations towards our Annual Campaign and exceeded \$10,000 towards our Endowment funds. Thank you to all of our donors and volunteers who have made this amazing legacy to our community possible.

Randy Russell Received 2012 Humanitarian of The Year Award



The Community Foundation of the Ozarks has recognized Randy Russell with the 23rd annual Humanitarian of the Year Award. The award recognizes a person who has personally sacrificed to give services, time and resources to helping others. Randy was proudly nominated by JLS for this award. Mr. Russell is a longtime advocate for children and the arts in Missouri. He was one of the first community members selected to serve on the JLS Community Advisory Council, a council that is dedicated to responding to community issues. He worked to help develop the JLS scholarship, now known as the Mary Riley Wolfe Scholarship that awards college bound ladies a scholarship based on community service. He now works as a Senior Program Officer for the Community Foundation of the Ozarks.

Some of his many accomplishments include: helped start the Partners in Education program that became a national model for business partnerships with schools; served as a mentor through the SPS/Administrator Mentoring Program from 2003-2006; serves on the Mayor's Commission for Children; serves on the Mayor's Commission of Springfield Executive Committee; works with The United Way of the Ozarks Early Childhood Initiative, serves on the Springfield R-12 "Kid First" Advisory Panel; served on the City of Springfield's initial Cultural Plan; serves on the Springfield Little Theatre Board and Every Kid Counts. He has also given countless volunteer hours over the years to First Night Springfield, UDA, Artsfest, Cider Days, and Springfield Regional Arts Council. Randy has not only shared his passion for the arts & humanities at the community level, he has also shared that passion with higher education by serving the Missouri State University-College of Arts and Letters Advisory Council since 2003.

Mr. Russell accepted the award and received a \$3,000 cash award. He donated the money to the Arts in Education Fund for the Springfield Arts Collaborative Endowment campaign.

Dr. Karen Scott Receives OHAF Child Health Advocate of the Year Award



The Association of Fundraising Professionals Ozarks Region Chapter has recognized Dr. Karen Scott with the Outstanding Child Health Advocate of the Year award. OHAF recognizes Dr. Scott as an outstanding advocate for local children's critical health issues. Dr. Scott was nominated for the award by JLS. She has been an advocate for children since she entered the teaching profession in 1976, serving the most high-risk students.

She sought new district policies that provided support for a diverse student population that included young mothers, emancipated youth and homeless students. She was quickly promoted to the Coordinator of Counseling and within a few years, Director of Student Support Services. There, Dr. Scott directed and supervised the work of Attendance Services, Health Services, Counseling, Title IV (Safe and Drug Free Schools), Minority Affairs and dropout prevention. Under her leadership and guidance, the Springfield Public Schools District received the largest grant ever awarded to the district and began innovative programming that provided gravely needed social workers in the schools. When the grant expired, she successfully lobbied the State for continuation of funding for the district's poorest schools. Dr. Scott was the driving force behind the highly successful Truancy Courts that were a unique collaboration between the schools and the judicial system.

Dr. Scott helped establish the non-profit agency Lost & Found with Shawn Askinosie. Dr. Scott's leadership and influence have changed the lives for more than 2,500 children who have been served by the group. She has also served on the Mayor's Commission for Children, Community Partnership of the Ozarks Education Committee, and many other councils.

Membership Recognition

The Junior League of Springfield is honored to have more than 600 outstanding women volunteering their time to complete its mission. Each year, members are recognized within the League for outstanding accomplishments. One award is the Cheri Clark Bouquet of Enthusiasm. It recognizes a member for dedication to the League and a positive attitude. The other award is the Lifetime Achievement Award for dedication to the League over time. DONE IN A DAY COMMUNITY PROJECTS 2012-2013



Newborns in Need - Warm Baby Project

Dozens of children were served by this project which ensures less fortunate families with babies have access to quilts, blankets, socks and sleepers for the winter months. Thirteen JLS members and \$5,000 were provided to complete this project.

SW Missouri Humane Society - It's Not Cool to Be Cruel

This is a new program designed to teach kids about caring for animals, and then make the connection that not only is it inappropriate to abuse animals, it's inappropriate for people to be abused, too. Volunteers assisted with an assembly and in-class presentations. JLS contributed \$4,500 and 25 volunteers to this event.

Springfield Council of PTAs

This program provides clothing to at-risk students of Springfield Public Schools. JLS provided \$500 and ten volunteers to assist during two Saturday mornings throughout the year.

The Kitchen - The Rare Breed Street Outreach

JLS provided \$996 and 25 volunteers to assemble hygiene kits and travel packs of food. This program aims to establish a street outreach program for homeless and at risk youth.

Ozarks Food Harvest - Weekend Backpack Program

Twenty-seven JLS volunteers spent hours sorting and packed over 1400 backpacks to provide at-risk children with nutritious food for the weekend. JLS donated \$5,000 toward this program.

Council of Churches - Ambassadors for Children - Kids Closet

This program provides clothing to kids in the foster care system. Six JLS member volunteers went shopping and purchased \$2500 in new clothing which served more than 800 children.

Boys & Girls Club of Springfield - Opening Doors to a Brighter Future

This project provided mental health services to at-risk youth in an environment that they were comfortable in and which did not require additional trips for the parents. JLS provided \$596 and six volunteers for this training event covering bullying and "Love and Logic".

Lighthouse - Family Education

This program was designed to diminish risk factors for child abuse and neglect: poverty, unemployment, low self-esteem, lack of social support, parenting skills, and coping skills by providing education about age appropriate behavior, positive discipline techniques, financial management, mental health and more. JLS provided \$563 and twelve volunteers to assist with food service, aided teaching staff in the classroom, and greeted families upon arrival. 60 parents and 40 children were served.

Ozarks Counseling Center - Keeping Your Cool

JLS provided \$519 and four volunteers to assist with this anger management program which teaches communication skills for both parents and children.

Cox Health Foundation - Safe Cribs Project

JLS provided \$1500 to purchase Pack-N-Play cribs and six volunteers to assist with training sessions on shaken baby syndrome.

Springfield Regional Arts Council - Art in the Park Summer Workshop Poetry

JLS provided \$1000 and five volunteers to assist with this program focusing on character development through poetry and creative writing.

Isabel's House, the Crisis Nursery of the Ozarks

IH Community Tour Day

JLS provided twenty volunteers and spent two days helping with games, food and tours during an open house for Isabel's House.

IH All Around Town Outreach

JLS provided six volunteers to deliver brochures to health care providers and other groups in the community in an attempt to educate them on the services that Isabel's House provides.

IH Early Childhood Ed Materials

JLS provided \$538 and ten volunteers to purchase and assemble craft kits so that families can continue working with their children once they leave Isabel's House.

IH Child Abuse & Neglect Awareness Month

JLS provided five volunteers to assist with collecting coloring sheets and selecting a winner whose art was placed on a billboard for Child Abuse and Neglect Awareness Month.

IH Kids Closet

JLS provided two volunteers and \$700 to purchase the clothing for the Isabel's House Kid's Closet which provides each child with a new outfit when they leave.

IH Oscar Experience

JLS provided eight volunteers to assist with the premier fundraiser for Isabel's House, Oscar Experience, by making attendees feel like royalty, assisting on the red carpet, greeting patrons and helping with a silent auction.

Junior League of Springfield Training Opportunities

JLS strives through all our commitments to meet all three aspects of our mission. Developing the potential of women happens continuously throughout the year but often goes unnoticed even by our own members.

JLS training benefits the community and provides women educational and training opportunities to better themselves in the following ways:

- JLS training allows members to serve on other boards throughout the community and provide leadership and guidance to others.
- Creates better career opportunities and leads to entrepreneurial confidence in members' own lives while allowing members to be charitable.
- Completed JLS projects benefit the community while training women on each project.

Training opportunities for the general membership include:

- Elevate, a once a year internal leadership seminar, preparing JLS members to lead committees, understand the budgeting process, our mission and current focus, and provide a better understanding of the structure of JLS.
- Lobby Day, an advocacy day with all Missouri Junior League organizations at the state Capitol meeting with legislators. There is a training session prior to this event to educate members on the lobbying process.
- Done In A Day, these are projects that JLS provides funding and volunteers for other 501c3 organizations to fulfill a need of that organization. Members who participate get training on other nonprofit projects, organizational skills, and leadership skills.

- ODI - Organizational Development Institute of the Association of Junior Leagues International, Inc. (AJLI) is a national convention that teaches in-depth strategies for Junior League leaders. JLS will send women who are interested in pursuing leadership roles to participate in these trainings.
- Children's Summit, a community awareness event hosted by JLS with community stakeholders where they tackle red flag issues in the community including the subject of prevention of child abuse and neglect.
- All members who serve in an appointed or elected position gain hands on training in areas such as budgeting, fundraising, advertising, management, and long-term planning for an entire fiscal year. Each member is encouraged to step into new roles to grow skills in multiple business functions.
- In 2012-2013 the Annual Campaign focused on the impact JLS has had in the community for the past 54 years. It trained members through fundraising, League and community awareness, reaching audiences through social media, public relations and public appearances.

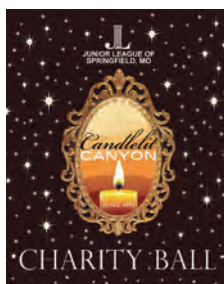

JLS Endowment Fund

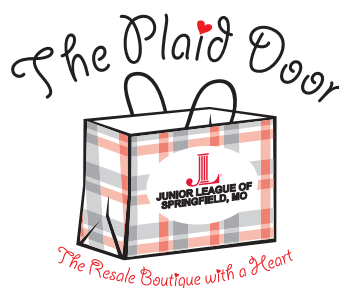


Plaid Door Resale Boutique

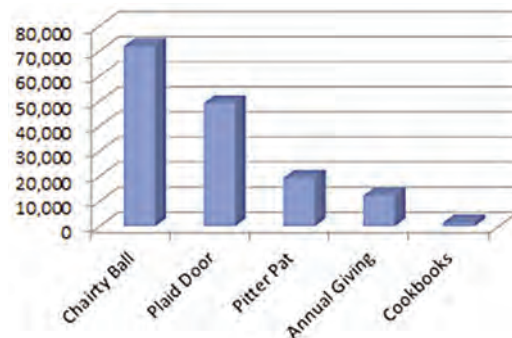
