

# **Membership Transformation Task Force: Looking Ahead**

This year, JLS embarked on a three-year Membership Transformation, led by a sixmember task force. Introduced and led by AJLI, "the goal of the Transformation Rollout Membership Model is to help Leagues adopt and implement a new approach to membership in the Junior League."

The new approach incorporates:

- Greater flexibility for members in deciding their level of community and League involvement
- Members' voices in deciding the direction of the League
- Onboarding that takes advantage of members' professional, personal and civic talents
- Opportunities for meaningful connections within and outside the League

Since summer 2018, our task force has participated in monthly webinars with the other Leagues on the same rollout schedule, known as our cohort. We also receive one-on-one check in calls with AJLI, webinars specifically geared toward the board and access to a plethora of resources from Leagues who have already fully implemented the new model. In December 2018, more than 50 women from JLS were asked to be a part of the transformation pilot group. This group will test out the new membership model for the 2019-20 JLS year.

AJLI as a whole, as well as our League, recognizes the face of the Junior League member is changing. Today's member may work full-time outside the home, and most members already serve on at least one community Board or volunteer committee when they join the League. Our members bring professional skills and experiences that are huge assets to the work of our League in Springfield. This new membership model seeks to better align members' skills and experiences with their desired League experiences.

Furthermore, today's member's level of commitment to JLS may ebb and flow based on her season of life. Under the new membership model, members will have a direct say in deciding their level of League involvement on an annual basis.

A member's experience will be described with the phrase, "your voice, your choice."

Should JLS decide to fully implement the transformation, the three-year rollout will

be completed in June 2021, allowing all members to share the experience of the pilot group.

Our task force is excited about the prospective change this transformation could bring to our League and to each individual member's experience. Other Leagues that have successfully implemented the transformation have seen increased engagement, previously untapped sources of League leadership and stronger outcomes for their Leagues and their communities.

We are anxious to move our League's membership into the future under this new model.

Congratulations to Linda, she truly exemplifies this through her work in the community and with JLS.




## Meet the Founders
